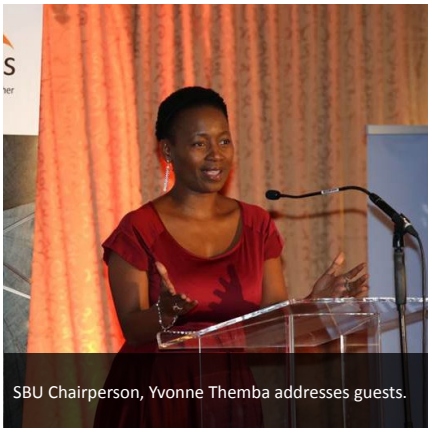

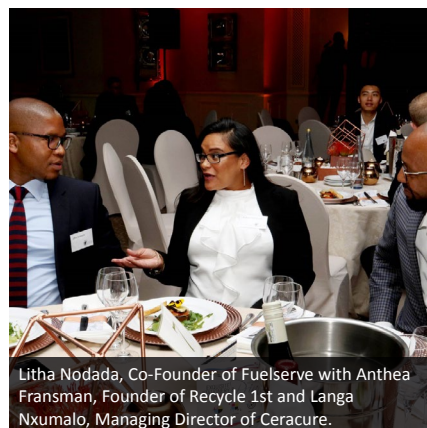

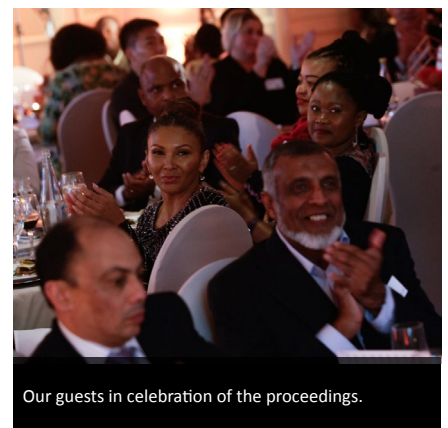

## ***Modi Mining awarded R158 million contract***

SBU's Mooinooi client, Modi Mining has been awarded a three-year, R158 million contract by mining giant South32. This comes after plans by JSE listed companies to create a more inclusive supplier landscape. The joint venture is a milestone for Modi Mining, as it is a realisation of its plans to be the supplier of choice to the mining industry.

Mike Fraser, COO of South32 has expressed an important need for a supportive environment that makes it possible for inclusive growth solutions to realise their full potential.

Since its inception in 2007, Modi Mining has continued to grow and offer services in the mining sector. This is the first core mining contract to be awarded to a 100 percent black-owned company and marks an important breakthrough in the development of black-owned businesses.

The partnership will create a number of job opportunities, as Modi Mining aims to source 80 to 90% of their labour from the local communities. The contract will see Modi Mining operating at the Wolvekrans Middleburg Complex, delivering sub-processes - including top soiling and stripping overburden.

## *The Johannesburg Incubator holds its second procurement workshop*



The Johannesburg incubator held their second procurement workshop on the 5 July 2017, the event was held at The Norton Rose Fullbright auditorium in the Sandton CBD. The focus of the workshop was to firstly provide our clients with information as to how to take advantage of the current enterprise and supplier development landscape, secondly introduce them to procurement opportunities from corporates who are purchase ready and are looking for solid businesses to work with, thirdly provide information on opportunities in the township economy and the Gauteng region and practical tips on how to navigate the public sector. Finally, the workshop presented a platform for entrepreneurs to network and provide each other support and advice.

The panel consisted of four speakers with adequate time allocated for presenting and questions. Famous brands opened the workshop by outlining their current ESD strategy and areas where they are lacking and are looking for proposals; they were followed by Rand Mutual Assurance which was able to secure 2 service providers at the event and 4 leads for upcoming tenders.

The next speaker was from the Gauteng Growth and Development Agency; they gave us an idea of where the province was going and sectors which required skills and investment. They have given our clients access to visiting international business delegations with the potential for investment and partnership with these companies. The final speaker was GG Alcock the author of Kasinomics, he gave an insightful talk on the township economy and its potential to create the next wave of successful entrepreneurs.

The event proved to be a success for both clients and speakers, relationships were built and business was done. We received positive feedback from all stakeholders and will strive to improve on the standard which has been set.

## Lephalale Incubator shows support on International Mandela Day

In celebration of Madiba's life and legacy, the Lephalale incubator committed their 67 minutes to Matshwara High School in Shongoane village, Lephalale. The objective of the incubator was to ensure that the local Grade 11 and Grade 12 learners are equipped with all the critical information needed to make the right choices for their careers and how they can choose entrepreneurship as an alternative career choice.

Madiba famously said, *"An educated, enlightened and informed population is one of the surest ways of promoting the health of a democracy"*.

Youth unemployment is a serious challenge in Lephalale with a majority of matriculants not having sufficient funds to further their studies and left without access to information about the different qualification options available.

Learners from Matshwara were coached on the university online application processes as well as bursaries and study assistance programmes. LEDA and SBU also provided information on how to start and grow their own businesses in support of encouraging the next generation of local youth entrepreneurs.

In keeping with this year's Mandela Day theme to fight poverty, 20 learners from impoverished families were also supported through food parcels while 250 of the Grade 11 and Grade 12 girls received sanitary towels.

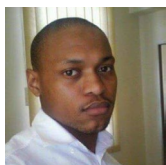

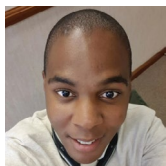
